Opinions in appealed cases should, under normal and usual circumstances, be issued not more than six months following the oral argument, or, if the matter is submitted without argument, not more than six months following the date the matter is taken under advisement. *See* AR12-001 ¶ B.3. These time standards apply to appeals and writs filed in the Supreme Court on or after April 3, 2012.
